EasyPASS CERTIFICATE FROM BUREAU VERITAS FAST TRACK CLEARANCE FOR IMPORTS

Bureau Veritas has been appointed by the **Ghana Standards Authority (GSA)** to verify, in the region of export and prior to shipment, the conformity of the goods to Ghanaian and/or international standards and issue the EasyPASS Certificate to facilitate and speed up customs clearance process of the goods in Ghana.

- Automotive products (*including new and used vehicles*)
- Chemical products (*except household chemical substances*)
- Mechanical materials and gas appliances
- Pulp of wood, paper and paper board
- Furniture (*wood and metal articles*)
- Safety (*Personal Protective Equipment*)
- Construction materials
- Fuel/Petroleum products
- Textile, textile articles and leatherware, including African prints
- Selected used products (*used clothes and footwear*)
