EasyPASS PROGRAMME

Bureau Veritas has been appointed by Ghana Standards Authority to implement the Ghana EasyPASS Programme in Ghana.

OBJECTIVES

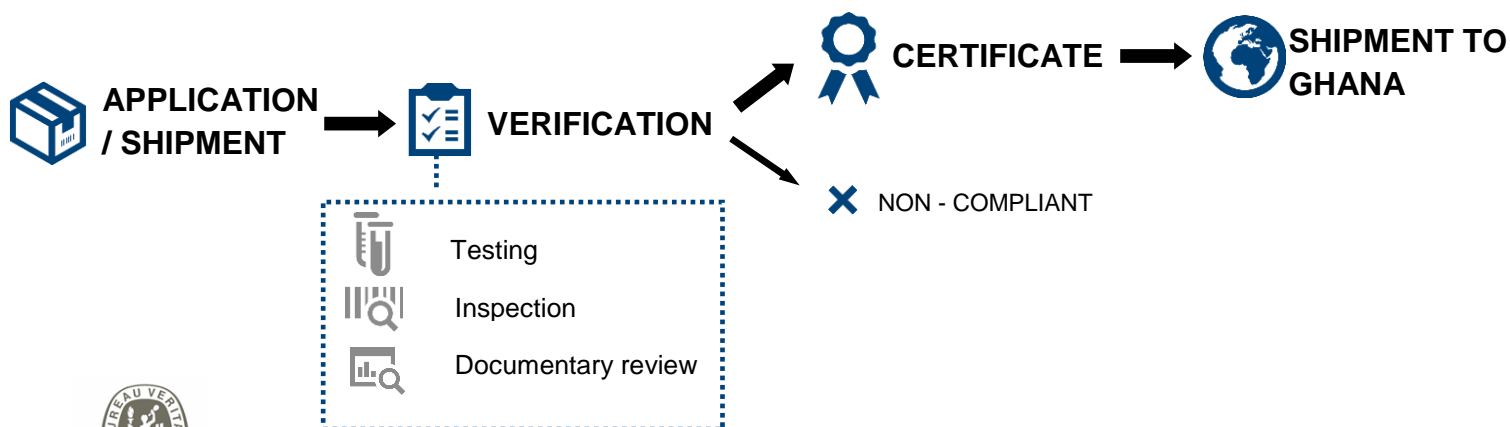
- Fast track clearance on arrival in Ghana
- Protection of the consumer and the environment
- Prevention of the importation of unsafe, sub-standard and/or counterfeit goods

TYPE OF PRODUCTS COVERED

- I. Toys, Games and Sports equipment
- II. Electrical and Electronics
- III. Automotive Products (including new and used vehicles)
- IV. Chemical Products (except household chemical substances)
- V. Mechanical Materials and Gas Appliances
- VI. Pulp of wood, paper and paper board
- VII. Furniture (Wood and Metal articles)
- VIII. Safety (Personal Protective Equipment)
- IX. Construction Materials
- X. Fuel/Petroleum Products
- XI. Textile, Textile Articles and Leatherware including African Prints
- XII. Selected Used Products (Used clothes and footwear)

Step 1 : Request for Certificate

Importer / Exporter lodges a Request for Certificate to a Bureau Veritas contact (please see next page). Said request should include :

- List, designation of goods intended to be exported, importer / exporter details (name, address, invoice, ...)
- Conformity documents available (ex: Third party certificate, Test reports, Reports of analysis according to QHSE - Quality, Health, Safety and Environment - standards)
- Information related to local and provisional date of availability of goods to carry out their physical inspection before shipment. (Filling up of the Request For Certificate (RFC) Form)

Step 2 : Documentary review / Testing

Bureau Veritas reviews all information provided and checks their adequacy against the Ghanaian standards. Laboratory testing / analysis are conducted on samples if necessary.

Step 3 : Inspection

Bureau Veritas checks that:

- Products comply with applicable standards
- Goods presented are those identified during the documentary review
- Goods match their description in the import / export documents
- If necessary, Bureau Veritas inspectors may take samples for additional assessment.

Step 4 : EasyPASS Certificate

Bureau Veritas checks the inspection report against the provided documents. Upon satisfactory results, a secured EasyPASS Certificate is issued, else, a Non-Conformity Report is produced.

Frequent and reliable exporters to Ghana may benefit from registration and licensing speeding up the verification process applied on their shipments
